## Nitro Software, a Global SaaS Leader in PDF Document Management and eSigning, Welcomes Cormac Whelan as Chief Executive Officer

Nitro, formerly a publicly traded company, was delisted from the Australian Stock Exchange (ASX) in April 2023 following majority shareholder approval of the Potentia Capital bid.

Nitro's Productivity Platform includes PDF tools, digital workflow automation, secure eSigning and identity-verification capabilities. Its analytics solution measures and quantifies ROI, usage and sustainability impact. Nitro supports more than 3 million licensed users and 13,000 business customers across 157 countries. It has outstanding customer retention ("stickiness") and continues to grow >20% on the top line.

"Nitro has been a leader in the PDF and eSign category for years," Whelan says. "I am joining at an exciting time and look forward to helping the company and its talented team navigate the next growth phase. We plan to accelerate our trajectory for product innovation, customer value and global market position."

"Cormac brings more than 30 years of experience as a software industry leader and multi-time CEO," says Simon Francis, Renovata & Company partner. "He has turned around and grown several public, private-equity and venture capital-backed companies, leading many of them to exit, most recently with a Warburg Pincus portfolio company. His experience is pivotal at this phase of Nitro's growth."

Before joining Nitro, Whelan was chairman of Qstream, an enterprise microlearning app, and chairman and investor of Boxever, a customer data platform acquired by Sitecore, a global leader in digital experience management software. He previously held C-level roles with companies including Voysis, an Al start-up acquired by Apple, as well as Mercator, Datalex Plc and Epicor Software Inc.

This is L Capital's third investment with Potentia. Past investments include Ascender (acquired by Ceridian) and Micromine (acquired by AspenTech, deal pending).
